



## **Privacy and Online Security Policy National Family Strengthening Network in the United States (NFSN-USA)**

The National Family Strengthening Network in the United States (NFSN-USA), a 501(c)(3) nonprofit corporation, is committed to protecting the privacy and security of individuals who visit our website. ### **1. Objectives and Scope**
